Abstract

The City and Village of Plymouth was first settled in the early 19th century and has since grown into a city of nearly 10,000 residents, covering over 2 square miles.

Scope and Content

The City and Village of Plymouth Government Documents record group is composed of various records related to the functioning and development of the city. The collection includes Tax Assessment rolls and special assessments that date from 1873 until 1985. The assessments consist of alphabetical listings of land owners with property descriptions with location. The fire department records date from 1895 and vary into the mid-1960s. The records include department meeting minutes, fire reports and some records from the Royal Hose Company. Birth and Death certificates of village and city residents cover dates from 1897 through 1978. Government operations records cover village and city ordinances annual reports, and other city plans and proceedings. The city and village election records found within the collection range from 1877 through 1920, with information on register voters in the early 1900s. Village of Common Council records are also included in the collection consist of meeting minutes from 1867-1914. Cemetery records on microfilm cover burial records from Riverside Cemetery. Final entries in the collection include Municipal court records, tax rolls, videos from the Plymouth Council on Aging from 2002-2004, assessed value tax record cards and real estate cards.
